Important Site Requirements

Failure to comply with the following requirements may result in stop-work orders, fines, or permit revocation:

Roadway Cleanliness: Contractors and property owners are responsible for ensuring that adjacent roads remain free of dirt, gravel, mud, and construction debris at all times. If tracking or dumping occurs, immediate cleanup is required.

Setback Verification: All building corners must be clearly staked or marked on-site before inspection to verify compliance with required setbacks. Construction without proper verification may result in removal or relocation at the owner's expense.

Drainage Requirements: Adequate site drainage must be maintained throughout construction. Install and maintain culverts, pipes, or other approved drainage solutions to prevent runoff onto neighboring properties or roadways.

Driveway Paving Requirement: Driveways must be paved a minimum of 15 feet from the edge of the roadway or to the Right-of-Way (ROW) limit, whichever is greater. Temporary surfaces (e.g., gravel) beyond this point must be stabilized.

TDOT Driveway Permits (Hwy 333): All driveways connecting to Highway 333 require prior approval and a Tennessee Department of Transportation permit. Before beginning any access work, contact TDOT Region 1 at (865) 594-2456.

Imported Fill Material: Any dirt or fill material brought onto the site in excess of 200 cubic yards must be clean and free of contaminants, including but not limited to demolition waste, hazardous materials, or invasive plant species. Proof of source and material quality may be required.
