Need to Know:

- Written verification (contract) of construction cost must be provided.
- Must provide a copy of septic permit from Blount County Department of Environmental Health (865)681-9502 regarding your sewage disposal system.
- The applicant agrees to keep the street (private or public) or roadway free of dirt, mud, stone, gravel etc.
- The existing drainage of ditches, swales etc. must be maintained with the use of pipes, culverts etc.
- All driveway entrances shall have a paved surface that extends 15' from the edge of the street's
 pavement or to the outer limit of the right-of-way, whichever is greater. Failure to Comply to the
 above stipulations may result in the revocation of this permit and/or assessment of clean up cost.
- Driveway permits on State of Tennessee roads must be obtained from the Tennessee Department of Transportation (865)594-2456.
- The roadway clean-up agreement applies to these state roads also.
- For any project that requires more than 200 cubic yards of off-site material to be hauled to the site, the applicant agrees that the material will be free of any hazardous material, toxins & etc.
