Other Business

Terri Hamil spoke about the damage to the town's road made by the Event Center located in Blount Co at the end of her road. She spoke about the excess traffic, large trucks, and equipment. I was mentioned that plans were in place to subdivide the property which would increase traffic and congestion on the road. Kim Rogers, City Manager gave a brief history of the situation along with what was promised and never delivered by the offending business. Discussion was around the utility and if the utility provided by the city could be used as leverage to require event center to create a new road or substantially upgrade the existing road. Kim Rogers was going to reach out to the county for assistance on the situation.

Discussion was made about the rules of order meetings would be governed by especially the gathering and engagement of community members just prior to and during the meetings. The new format that was followed during this meeting would be in place for future use.

Jordan Rockwell, planner said with his help the city needs to draft changes to it's subdivision regulations along with zoning map to ensure positive growth.
